IV. OPEN FORUM/DISCUSSION

A. Mike:

1. Sisu visit to deliver the check
 - a. I received a tour of the facility and a further explanation for what the organization does. They take in youths between the ages of 15-24 (separated by age) and provide support that includes on-site doctors and therapists. 1 youth can be covered for 49 days for about \$1,000. We raised funds to cover 4
 - b. They need help with cleaning products

B. Lashay

1. We have set a reputation on the circuit for being one of the most hospitable courts for Coronation events.
2. Thanks, from Joey to the membership and to Adrian for teaching them how to organize the event.

C. Ian

1. OKC pride event/parade: Fee of \$300 to participate
 - a. It has been decided we are not doing the parade given the price point

D. Jordan

THE IMPERIAL COURT OF ALL OKLAHOMA

1. Found an organization that offers therapy and support to families caring for members with Autism. Pending more details from them on possible 501c2 status and what they do
 2. Almost completed planning for the ICP ball in September
 3. Stressed the impact of making someone feel seen, even if it is just through a supportive hug
- E. Haze/Jordan: Questions to the membership
1. What worked well from last year that you would like to see continued this year?
 - a. Ray: Would like to see more involvement outside of the bars. Social events for members like games, movies, etc.
 - b. Jarrod: More outreach events to support the community
 - c. Joey: Suggests a retreat weekend for the court
 2. What do you think we can do as an organization to ensure you feel more seen and heard?
 - a. Ray: Snacks a shows
 - b. Lashay: Suggesting we socialize with the community more at events
 - Joey: We tend to fill up seating at events. We should consider some form of priority seating so that others from the community can sit closer to performers when attending our events
 3. What do you feel you need help with the most? Be those performances, emceeing, make up, etc.?
 - a. Lyndsay: Performance Anxiety
 - b. Lashay: Hair care tips for those looking to learn ways to care for their wigs. It can be a zoom call. Can do the same with makeup and have a night to do both
 - c. Xandria suggests we have a group in the membership that can help facilitate support for those with performance anxiety and stage fright
 - Lennox suggests having someone behind the curtain for encouragement before performances
 - Joey: Suggests having a stage manager whose responsibility would be helping maintain set order and readiness for performances, backstage dressing and assistance, and additional encouragement. We could add a section for this to the event form and the emcee form
 - Ray: Suggests making it the show hosts' responsibility to stage manage unless emceeing. Then they will determine who will fill that role
 - Jordan: Suggests adjusting the even form so that Host 1 is the stage manager (unless emceeing)
 - d. Steven: Knows some exercise techniques that could help before a performance and is willing to share
 - e. Adrian: Knows some practice techniques that can also help. Also suggests having some show themes that can help those seeking assistance with performance.
 - EX) Duet show where performers with stage anxieties partner with an experienced performer

- f. Lashay: Adopt a monarch: Members choose a monarch as their 'mentor' of sorts that can guide them through history and performance prep. They will then do a show together
- 4. What would you like to see from the Royal Family this year?
 - a. Joey: Reiterating snacks at shows
- 5. George: Having questions like these at the last minute does not give a good opportunity for answer
 - a. A forms page will be created and uploaded so members who need more time to consider the questions can chime in with feedback later
- 6. Aqua: Request for the membership to bring creativity and enthusiasm to shows during the year instead of holding it for the coronation

F. Lashay

- 1. Membership safety
 - a. Implementing a buddy system at events/shows to make sure everyone is safe
 - b. Making sure no one is going to their cars alone
 - c. Making sure Ian is not going with the money bag along
 - d. Notifying the group when someone has made it home or is traveling
- 2. Adrian is looking into software like life360 that we can use. Pending further discussion
