### ICAO Monarch Requirements

Applicants must meet all requirements as of January 31 of the current reign year:

1. Applicants must be at least twenty-one (21) years of age.
2. Applicant must be a continuous member from Investiture of the current reign and be a member in good standing at the date of application availability.
3. Applicant must have attended 75% of the meetings (combined or membership) during the current reign through January 31. Only two excused absences are allowed in calculation of eligibility.
4. Applicants must have attended and participated in 75% of all ICAO events from Investiture of the current reign through January 31. Only two excused absences are allowed in calculation of eligibility.
5. Applicants must have attended a minimum of one (1) Out-of-State, State function.
6. Applicants must have produced a minimum of one (1) fundraising event during the current reign individually or with the assistance of a Reigning or Past Monarch with a positive amount of at least one hundred dollars (\$100.)
7. Applicants must be able to prove they can afford both the time and financial requirements of the position they seek.
8. ICPs and PRs of the current reign with aspirations must have also successfully completed any requirements of said title by January 31<sup>st</sup> of the current reign, unless granted extension or leniency.

For full list of conditions for the office of Monarch please see the ICAO Bylaws or PNPs.

Applicants must also submit a letter along with the application to explain:

1. Vision and goals if elected as monarch.
2. Qualifications for the position.
3. Financial status and/or means to support travel requirements.
4. Other organizations you belong to or work with.
5. Knowledge and experience with fundraising.

Application fee of \$100 (cash, money order, or certified check):

1. Fee must be submitted with the application.
2. The application fee is refundable only if the applicant does not become a clear candidate for a monarch.
3. The \$100 fee for accepted candidates will provide a ticket to Coronation and all activities of the Coronation weekend.

The applicants for candidacy will be reviewed and interviewed by the Screening Committee.

Each candidate will be informed privately of the Screening Committee's decision within 24 hours of that candidate's interview. The official announcement of candidates will be determined by the Board of Directors.

Candidates may NOT conduct any pre-campaigning before the official announcement of candidates. Pre-campaigning will result in automatic disqualification from candidacy. Discussion with anyone other than the Board of Directors prior to the official announcement of candidates is considered pre-campaigning.

Candidate campaigning and fundraisers shall be between the date of the official announcement of candidates and Friday, April 02, 2026, at 11:59 p.m.

Voting will take place one week prior to Coronation. Announcement of the election winner(s) will be made at Coronation. Candidates are required to attend as many functions as possible prior to Voting and Coronation.

Once cleared, the candidate is responsible for meeting the requirements set forth in Section 10.15 – 10.17 of the ICAO PNPs.

Reign XVI Deadlines and applicable dates are as follows:

1. Application deadline: Saturday, February 14, 2026, at 11:59 p.m.
2. Screening Interviews: Saturday, February 21, 2026, at OKEQ in Tulsa
3. Candidate Announcement: Saturday, February 28, 2026, at the White Crow
4. Public Voting: Saturday, April 4, 2026, 1pm – 5pm in Tulsa @ OKEQ  
Saturday, April 4, 2026, 1pm – 5pm in OKC @ Other Options
5. Coronation XVIII: Saturday, April 11, 2026
